

Migration and mobility are among the most fundamental changes of societies worldwide and they are a central ingredient of globalization. Migration research has long shown that migration is not a process with just one clearly defined starting and end point. In contrast, it has been described as a process or a career. Yet, research on subsequent mobility in individuals' life courses following the initial migration is still a rather young topic. The conference focuses on mobility after international migration, its causes, patterns, and effects. We want to inquire about 'mobility after migration' for individuals belonging to various groups of migrants, and across generations. We are interested in the contexts that shape opportunities for mobility on the micro-, meso- and macrolevel, such as local, national or European policies. The papers are based on empirical studies, using both quantitative and qualitative approaches and set in different parts of the world, as well as theoretical contributions, addressing the relation between mobility and migration.

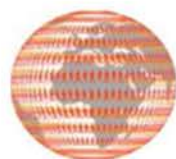
